ORDER APPROVING LEASE.

It is therefore, by this Court, ordered, adjudged and decreed that that certain oil and gas mining lease executed, acknowledged and delivered to the said Martin F. Smith and Guy L. Reed, covering the N 1/2 of the S. E. 14/ and the S. E. 1/4 of the N. E. L/4 and the S 1/2 of the S 1/2 of the S. W. 1/4 and the N. E. 1/4 of Section 4, T^ownship 19 North, Range 10 East, by Tuckabache as sole heir of Ned Tuckabatchee, deceased, be and the same is hereby in all its terms, covenants and agreements approved, ratified and declared valid.
