

half of the Company by its President or Vice President, and that its corporate seal is thereto affixed and attested by its Secretary or an Assistant Secretary, and that such bonds be issued, certified and delivered in the form and manner and upon the terms and conditions and for the purposes set forth in this indenture, and that a fac-simile signature of the treasurer of the Company to each of the coupons attached to the said bonds be adopted, to have the same force and effect as if such coupons were signed by the Treasurer in person:

NOW THEREFORE, THIS INDENTURE WITNESSETH:

That in order to secure the payment of principal and interest of all of the said three hundred and forty, second mortgage six year, six per cent., sinking fund, gold bonds of the Company at any time issued and onstanding under this indenture, and in consideration of the premises and of the purchase and acceptance of such bonds by the holders thereof, and of the sum of ten dollars to it duly paid by the Trustee, the receipt whereof is hereby acknowledged, the Company has granted, bargained, sold, aliened, remised, released, conveyed, confirmed, assigned, transferred, set over and mortgaged, and by these presents does grant, bargain, sell alien, remise, release, convey, confirm, assign, transfer, set over and mortgage unto the said Trustee, its successors and assigns, the following:

1. All that certain system of gas pipe lines described as follows: A six inch trunk line which begins at a point about two hundred feet west of the intersection of the Northeast corner of section three, and the Northwest corner of section two in township nineteen, North, range thirteen East in Tulsa County, Oklahoma, and runs thence parallel with the Cherokee-Creek nation line to the limits of the city of Tulsa, Oklahoma, a distance of about four miles; also another six inch trunk line which begins at the limits of the said city of Tulsa and runs directly North therefrom and parallel with the Osage-Cherokee Nation line a distance of one mile; also a five inch trunk line which begins at the Northern terminus of the last mentioned six inch trunk line and runs thence directly North a distance of about four and one-half miles; also a two inch line which begins at the Northern terminus of the said five inch line and runs thence directly East to the town of Turley, Oklahoma, a distance of about two miles; also a four inch line which begins about one mile North of Tulsa, at a point where the above mentioned five and six inch lines join and runs thence Northwardly into the Osage Nation a distance of about five miles. Together with all extensions, feeders, gathering and branch lines to or from the above mentioned lines and all valves, appliances, fittings equipment, fixtures, structures and property belonging to or connected therewith or to such extensions, feeders, branch and gathering lines and also all rights of way, easements, privileges, and grants upon or under which the said lines, extensions, feeders, branch and gathering lines are laid.

2. All other trunk gas pipe lines hereafter constructed, acquired, feeders and gathering and branch lines and all pumping, compressor or measuring stations, boilers and engines, drips, valves, reducers, meters, appliances, fittings, equipment, fixtures, structures machinery and property hereafter constructed, acquired or owned by the Company, and all rights of way, easements, privileges and grants upon or under which such trunk lines and their extensions, feeders and gathering lines and branch lines are laid. All of which as and when from time to time constructed,
