

The parts or portions of the said leasehold hereby conveyed and mortgaged being described as follows:

(a) Commencing at a point on the boundary line between the Osage and Cherokee Reservations at a point one mile north of the southeast corner of the Osage Indian reservation in Oklahoma; running thence north on said boundary line twelve miles to the southeast corner of Section Twentyseven, Township Twenty-two north, Range Twelve east; running thence west on the section line a distance of nine and one-half miles to the southwest corner of Section Thirty, Township Twenty-two north, Range Eleven east; running thence due south on the range line a distance of twelve and one-half miles, more or less, to the north line of lands leased to the Hartford Osage Illuminating Oil Company of Hartford, Connecticut; running thence east along the north boundary line of lands of the said Hartford Osage Illuminating Oil Company a distance of about three miles; running thence due north on the section line one-half a mile; running thence east along the north boundary line of said lands of Hartford Osage Illuminating Oil Company a distance of about six miles to the point or place of beginning and containing 77,994.43 acres, more or less.

(b) Commencing at the northwest corner of the piece of land last above described and lettered (a), such corner being the southwest corner of Section Thirty, Township Twenty-two, Range Eleven east, and the southeast corner of Section Twenty-five, Township Twenty-two, Range Ten east; running thence west six miles on the section line to the southwest corner of Section Thirty, Township Twenty-two Range Ten east; and the southeast corner of Section Twentyfive, Township Twenty-two Range Nine east; running thence south on the line between ranges Nine and Ten to the Arkansas River; running thence southwardly along the said river to the northwest corner of the present Hartford Osage Illuminating Oil Company's lands; running thence eastwardly along the north boundary line of the said Hartford Osage Illuminating Oil Company's lands to the west line of lands formerly leased to Guffey and Galey, being the piece last above described and lettered (a); running thence northwardly along the west boundary line of the said lands to the point or place of beginning, and containing 41,192.80 acres, more or less.

TOGETHER, also, with so much of the said oil and gas mining lease itself and the leasehold estates thereby created, as applies, governs and binds the two portions of the leaseholds thereof last above described and lettered (a) and (b).

Also all right, title, interest, claim and demand received, acquired, held or owned by the Company under or by reason of that certain contract dated January 25, 1910 and made between the Indian Territory Illuminating Oil Company of the one part and the Company of the second part, whereby the said Indian Territory Illuminating Oil Company sold, assigned and transferred to the Company its right, title and ^{belonging thereto in or on the two pieces of land described} interest in the gas, gas rights and property in paragraph 5 hereof and lettered therein (a) and (b) and in and to the pipe line system described in paragraph 1 hereof.

And also all other oil and gas mining leases, lease holds, ^{Leases,} grants and rights wherever situate, now or hereafter owned by the Company, and all oil and gas wells drilled or to be drilled thereon, and all drive pipe, casing, tubing, derricks, machinery, appliances, equipment, fitting, fixtures and property connected ^{or to be connected} there-
