Edwards and Mary Alice Edwards for a consideration of Forty Eight Hundred (\$4800.00) Dollars cash in hand heretofore paid, by the said Edwards, receipt of which is hereby acknowledged and that the same is a fair and reasonable consideration for said above described lands, and the Petitioners further ask that the Court enter a decree approving said sale and Petitioners further represent that this conveyance and petition is made for the purpose of effecting a valid conveyance of said lands for your petitioners to the said N. Edwards and Mary Alice Edwards and to correct any errors that heretofore made in convenances heretofore executed.
