RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS: That ,

Whereas, on the 27th day of August, 1909, Pink W. Watson, guardian of Ioan V. Watson, minor, under and by authority of an order of the County Court of Tulsa County, State of Oklahoma, sitting in Probate in the City of Tulsa, said County and State, in Probate case No. 193, did assign, transfer and set over to S. R.
