Said leases being executed as authorized by order of this Court, to Gardner Steele of Tulsa, Oklahoma; and it appearing to this Court that the said order heretofore made in this matter for the leasing of the allotments of the minors for oil, and gas purposes has been fully complied with, and the Court being fully advised in the premises,

BE IT ORDERED, adjudged and decreed, That the said oil and gas mining leases executed by G. W. Hutchins as guardian of Fred, Jake and Wiley Gaskine, minors, respectively, to Gardner Steele of Tulsa, Oklahoma, and dated February 5, 1910, for a term of ten years and as long thereafter as oil or gas is produced therefrom, embracing the three above described allotments respectively, shall be and the same hereby are in all respects, terms, covenants and conditions, confirmed and approved.
