ASSIGNMENT OF LEASE TO ROBERT OGLESBY FROM E. H. BISPHAM.

KNOW ALL MEN BY THESE PRESENTS, That I, E. H. Bispham, lessee named in a certain oil and gas lease given by Vince Littleton, Guardian of Nelson Littleton, a minor, dated November 23, 1909, and recorded among the land records of Tulsa County, State of Oklahoma, for and in consideration of the sum of three hundred dollars (\$300.00) to me in hand paid by Robert Oglesby, of Tulsa, State of Oklahoma, the receipt whereof is hereby acknowledged, have granted, assigned and set over and by these presents do grant, assign and set over to Robert Oglesby, his personal representatives and assigns all my leasehold interest in and to the southeast quarter of the southwest quarter and the east twenty acres and the east twenty acres of the west twenty-one and seventy-eight hundredths of lot four all in section seven, township nineteen north range ten east as represented by a certain lease dated November 23th, 1909, and recorded among the land records of Tulsa County, State of Oklahoma, from Vince Littleton, guardian of Nelson Littleton, a minor, to the present grantor.
