wife of Mounds, Oklahoma County, and State of Oklahoma, parties of the first part, and Annex Oil & Gas Company a corporation of Tulsa, Oklahoma, parties of the second part.

WITNESSETH, That the parties of the first part, in consideration of the covenants and agreements hereinafter contained and of the sum of One Pollars, (5----), the receipt of which is hereby a cknowledged, does hereby demise, let and grant unto the part of the second part all the oil and gas in or under ALL that vertain tract of land, situate in Township, Tulsa, County, State of Oklahoma, DESCREIFED as follows, to-wit:

North West Quarter of Section Fifteen Township Sixteen North Range Thirteen Containing One Hundred & Sixty (160) acres , more or less, According East. to the Government Survey thereof.
