west Quarter and the West Half of the Northwest Quarter of the Southwest Quarter and the southwest quarter of Section Twenty-two, all in Township nineteen North, and Range Ten East of the Indian Meridian, in Tulsa County, State of Oklahoma.

ORDER.

Now on this 8th day of March, 1910, comes on to be heard the petition and application of Tilda Harjo and Willie Harjo, husband and wife, filed in open court, praying for the approval by the court of a deed this day executed by the said Tilda Harjo and Willie Harjo to one John F. Hayden of Tulsa, Oklahoma, conveying unto the said John F. Hayden all of their right, title, and interest in and to the following described lands, to-wit:

The South East Quarter of the North East Quarter and the North East Quarter of the South East Quarter of Section Twenty-one (21), and the West Half of the south West Quarter of the North West Quarter and the West Half of the North West Quarter of the South West Quarter and the South West Quarter of the South West Quarter of Section Twenty-two (22), all in township Nineteen (19) North, and Range Ten (10) East of the Indian Meridian, in Tülsa Gounty, Oklahoma;

Said deed of conveyance being presented to the court with the presentation of their said petition.

And the court having examined said petitioners, Tilda Harjo and Willie Harjo, in open court; and it appearing to the court that the said Tilda Harjo is an heir at law of the said George Givens, deceased, and that as such heir at law is entitled to an undivided one-half inter est in and to the lands of said George Givens , deceased, and described above; and that thesaid Willie Harjo is the husband of the said Tilda Harjo and it aprearing to the court that the said George Given resided during his life time in what is now McIntosh County, and State of Oklahoma, and died therein in the spring of 1900; and it further appearing to the court that the said George Given died intestate and without intue, and was a fullblood Creek Indian and duly enrolled upon the tribal rolls as such, as number 9984; and that Tilda Harjo and Willie Harjo, her husband are each full-blood Creek Indians, duly enrolled upon the tribal rolls, Tilda Harjo as number 5277 and Willie Harjo as number 5276; and that said land hereinbefore described is the allotment of the said George Given deceased; the court further finds that the consideration of \$350.00 paid by the said grantee, John F. Hayden of Tulsa, Oklahoma, is a fair and adequate consideration for said land and that the sale and conveyance of said land has been fairly conducted, and that all of the parties thereto have acted in good faith; and that said sale is heneficial to the said Tilda Ha rjo and Willie Harjo, her husband; and that the deed therefor is in proper form and should be approved by this court; and the court being well and sufficiently advised in the premises;

It is by the court considered, adjudged, and ordered that the prayer of the petition of said Tilda Harjo and Willie Harjo, husband and wife, he and the same is hereby granted, and that the warranty deed from the said Tilda Harjo and Willie Harjo to he the said John F. Hayden for all their right, title, and interest in and to the lands hereinbefore mentioned and described, presented in open court, he and the same is hereby in all things ratified, confirmed, and approved; and it is further ordered that a certified copy of this order he endorsed upon or attached to said deed.
