to the secretary of the Interior as herein provided shall cease, and all payments rerequired to be made to the United States Indian Agent shall thereafter be made to lessor or the ten owner of said land; and changes in regulations thereafter made by the Secretary of the Interior applicable to oil and gas leases shall not apply to this lease.

13. Each and every clause and covenant of this indenture shall extend to the heirs, executors, administrators, successors, and lawful assigns of the partieshereto.
