

1/8 of all oil produced , for \$150 for each gas well from which gas shall be used for other than operating purposes, and for \$80 in advance for each twelve months after date of said leases that a well shall not be drilled, and that said guardian in all things complied with order of this court heretofore entered herein.

It is therefore considered, ordered and decreed and said leases for oil and gas purposes as heretofore stated and upon the terms and considerations mentioned above are hereby confirmed and approved.
