Now, Therefore, I, the undersigned, the Principal Chief of the Cherokee Nation, do, by virtue of the power and authority vested in me by the aforesaid Act of the Congress of the United States, hereby grant, sell and convey unto the said Joseph E. Daniel his heirs and assigns forever, all the right, title and interest of the Cherokee Nation, aforesaid, in and to Lot numbered 3 in Block numbered 24 in the town of Owasso, Okla. formerly Cherokee Nation, Indian Territory, and according to the plat thereof on file as aforesaid.

IN WITNESS WHEREOF, I, the Principal Chief of the Cherokee wation, have hereunto set my hand and caused the Great Seal of said nation to be affixed at the date hereinafter shown.
