 Lela Watson, a minor. } ORDER APPROVING AND CONFIRMING OIL AND GAS MINING LEASE TO MINOR'S
~~LEASE.~~ *Lands.*

An order having been made by this Court on the 17 day of March, A. D. , 1910, authorizing Santa Watson, Guardian of the person and estate of Lela Watson, a minor, to execute an oil and gas lease to Joseph Bruner upon lands described as follows, to wit:

E2 NW4 & NW4 NW4 & SW4 NW4 Sec 25, Township 19 North, Range 10 East Indian Meridian and afterwards, to wit: on the 17 day of March A. D. , 1910, said Santa Watson, Guardian having made to this Court a return of his proceedings under the said order verified by his affidavit in due form of law. This Court having examined the said return, and examined in open Court, the said Santa Watson, Guardian, and it appearing to the satisfaction of this Court:

That in persuance of said order authorizing a sale of lease for oil and gas mining purposes upon the lands hereinbefore described,, Santa Watson, Guardian, caused waiver of the notice of the time and place of holding said sale to be made and given by Santa Watson, and Annie Watson, next of kin to said minor; The Court further finds that Santa Watson is the duly appointed, qualified and acting Guardian of Lela Watson, a minor, and that said minor is a legal resident of Okfuskee County, Oklahoma; That the leasing of said lands was legally made and fairly conducted; that the sum paid for said lease was not disproportionate to the value of said lease; that Joseph Bruner became a purchaser and lessee of said oil and gas lease for the sum of \$80.00, he being the highest and best bidder, and the said sum being the highest sum so bid.

The Court further finds that the said Santa Watson, Guardian in all things proceeded and conducted and managed such sale of lease as by the Statute in such case made and provided; that said minor is a citizen of the Creek Nation, and that it is necessary that said lands of said minor be leased for oils and gas purposes for proper maintenances, education and support of said minor child; and the Court further finds that there are no objections confirmation and approval of such sale of lease.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the court that the said sale of lease be, and is hereby confirmed and approved and declared valid in all respects.
