ASSIGNMENT OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS, That The Deming Investment Company, (a corporation) in consideration of the sum of Eight Thousand Dollars (\$8000) to it in hand paid, the receipt whereof is hereby acknowledged, does hereby sell, assign, transfer, set over and convey unto Swarthmore College (a corporation) its successors and assigns, one certain mortgage dated the 11th day of December A. D. 1908, executed by Reuben K. Parkhurst and Inez E. Parkhurst, his wife, to The Deming Investment Company, and given to secure the payment of Ten Thousand Dollars (\$10,000) and the interest thereon, and duly filed for record in the office of the Register of Deeds of Tulsa County, Oklahoma; and recorded in Book 39, on page 475, on the 23rd day of December 1908.

It is understood by the parties hereto that said mortgage was given originally to secure an indebtedness of Ten Thousand Dollars (\$10,000) and that Two Thousand (\$2000) of said indebtedness has been paid, and that in consideration of such payment, lot 5 in block 40 of the City of Tulsa, Oklahoma has been released from the lien of said mortgage, and that there remains due of said indebtedness Eight Thousand Dollars (\$8000) of principal, which is secured by said mortgage on lot 2 block 40 in the city of Tulsa, the notes representing said remainder of indebtedness having been duly assigned with said mortgage to Swarthmore College.
