CONFIRMATION ORDER.

Now on this 28 day of February, 1910, this matter comes on for hearing on the confirmation of certain oil and gas leases, executed by Thomas J. Jones, as guardian of the estates of Thomas C. Jones, Frank Jones, Raymon B. Jones, Freddie Jones and Pearlle, Inez Jones, minors, to Thomas White and J.K. Ronne, upon the allotments of said minors located in Tulsa County, Oklahoma, authorized and empowered in pursuant to order of this Court dated the 28" day of February, 1910.

And said minors appearing by their guardian Thomas J. Jones, and testimony being taken in open Court, and the Court being advised in the premises finds:

That the said Thomas J. Jones, is the duly appointed, qualified and acting guardian of said minors, and said minors are residents of said County and State, residing with their father Thomas J. Jones and Mary E. Jones, their mother, and that the said father and mother are the next of kin and only persons interested in this matter, and have filed in this case, their written waiver for the hearing of the petition for the sale of oil and gas leases, and also request the execution of such leases by said guardian upon the lands of said minors hereinafter described.

And the Court further finds that the said minors are the owners of the following described tracts of land, to-wit:

The S. W. $\frac{1}{4}$ of the N. W. $\frac{1}{4}$ and the N. W. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of the N. W. $\frac{1}{4}$ of Section 5, Township 20 north, Range 14 East, being the allotment of Thomas C. Jones and containing 50 acres more or less.

Lot 4, of Section 5, Township 20 North, Range 14, East, being the allotment of Frank Jones, and containing 39.94 acres, more or less.

The S. W. $\frac{1}{4}$ of the S. W. $\frac{1}{4}$ of Section 32, Township 21 North, Range 14 East, being the allotment of Freddie Jones, and containing 40 acres, more or less.

The S. $\frac{1}{2}$ of the S. E. $\frac{1}{4}$ of the N. W. $\frac{1}{4}$ and the N. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of the N. W. $\frac{1}{4}$ and the S. 20 acres of Lot 3, Section 5, Township 20 North, Range 14 East, being the allotment of Pearlle Inez Jones, and containing 50 acres more or less.

The S. W. $\frac{1}{4}$ of the N. W. $\frac{1}{4}$ of Section 32, Township 21 North, Range 14 East, being the allotment of Raymon B. Jones, and containing 40 acres, more or less.

And the Court further finds that the above described land is in what is known as the oil and gas belt, and that it would be to the best interests of said minors and their estates, that good and valid leases should be made and confirmed by this Court on said land. That said lands are unproductive and that said minors receive no income therefrom, nor have said minors any income from any source. That said minors have no property, real or personal, other than above described, and that their income is insufficient for their support, maintenance and
