blood Creek Indian, duly enrolled upon the tribal rolls of said Creek Nation, opposite Roll number 9984; and that the said Okfuske Harjo, the petitioner herein, is a full-blood Creek Indian, and duly enrolled as such upon the tribal rolls of the Creek Nation opposite roll number 7816;

And it further appearing to the court that the exact interest of said Dkfuske Harjo in and to the said lands of the said George Given, deceased, cannot be definitely determined, but that whatever interest he has in by virtue of being the husband of one Katie, who was the daughter of one John, the said John being a full blood Creek Indian, and being the brother of One Pohye, a full-blood Creek Indian, who was the grand morther of George Given, deceased;

And it further appearing to the court that the consideration of fifty dollars, paid by the said grantes, John F. Hayden, is an adequate consideration for the interest of the said Okfuske Harjo in the said land; and that the sale and conveyance thereof has been fairly conducted, and that all of the parties hereto have acted in good faith; and that said sale is beneficial to the said Okfuske Harjo; and that the deed therefore is in proper form, and should be approved by this court: and being sufficiently advised in the premises;

It is therefore, by the court, considered, adjudged and ordered that the petition of the said Okfuske Harjo be and the same is hereby granted and that the warranty deed from the said Okfuske Harjo to John F. Hayden of Tulsa, Oklahoma, for all his right title, and interest in the lands hereinbefore mentioned and described, presented in open court, be, and the same is, hereby, in all things, ratified, confirmed, and approved; and it is further ordered that a certified copy of this order be endorsed upon or attached to the said deed.
