COMPARED THIS LEASE made and entered into this 16 day of April 1910, by and between William Bigpond, kareinafterzentimixtheximmenx Creek Roll #6491 of Depew, Oklahoma, hereinafter called the lessor and J.M. Ricks, of Sapulpa, Oklahoma, hereinafter called the lessee, WITNESSETH;

1. That the lessor owns the following described real estate and premises, situated in Tulsa County, Oklahoma, to-wit:
