his return of sale in this court duly verified as required by law, and that said return of sale was duly set for hearing on April 11th 1910, and it now appearing that Ellen Frances Ruysschaert has submitted and filed in this court his bid for said land in the sum of \$650.00 and that said sum so bid by said Ellen Frances Ruysschaert exceeds the original bid of said S.R. Lewis by more than ten per cent exclusive of the costs of a new sale, and that said sum of \$650.00 so bid by said Ellen Frances Ruysschaert is more than the appraised value of said real estate; that it would be to the best interest of said minor that the bid of said Ellen Ruysschaert be accepted; that said sale was legally made and fairly conducted, and that said sum is not disproportionate to the value of the land sold.

And it further appearing to the court that said guardian has given an additional bond in the sum of \$1500.00 as required by the decree of sale and has in all things proceeded, conducted and managed such sale as required by the statute in such cases made and provided and as by said order of sale required and directed.
