The court finds that the notice of the sale of the land above described has been given, as provided by law and as prescribed by the order of Sale; that the guardian has in all things proceeded and conducted and managed said sale as required by law and as directed by this court; that the sale was fairly made and legally conducted; that the said Seth Ely and J.E.
