ASSIGNMENT OF OIL AND GAS LEASE.

This assignment made and executed by T.E. Farr as party of the first part, to S.E. Bailey, of Kiefer, Oklahoma, party of the second part.

WITNESSETH, Whereas, on the 8th day of February, 1910, Fannie Hawkins, now White, made and executed to the party of the first part a certain oil and gas lease, covering the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 2, Township 17 North, Range 12 East, containing forty (40) acres more or less, same being the homestead allotment of the said Fannie Hawkins, now White; and

Whereas, on the 8th day of February, 1910, the said Fannie Hawkins made and executed to the party of the first part an oil and gas lease, covering the following described real estate, situated in Tulsa County, Oklahoma: The NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 2, Township 17 North range 12 East, containing forty (40) acres more or less, same being a part of the surplus allotment of the said Fannie Hawkins now White; and

Whereas, on the 31st day of March 1910, O.P.H. Butler, Trustee, of Muskogee, Oklahoma, made and executed an oil and gas lease to the party of the first part, covering the following described real estate, situated in Tulsa County, Oklahoma, to-wit: Lot 1 of section 2, Township 17 North, Range 12 East, containing forty (40) acres more or less same being the identical property described above as part of the surplus allotment of the said Fannie Hawkins, now White.

Now, Therefore, for and in consideration of the sum of One Dollar in hand paid by the second party, and other good and valuable consideration, the party of the first part, the said T.E. Farr, assigns and sets over, and by these presents does hereby sell, assign and set over to the said party of the second part S.E. Bailey, his heirs and assigns forever, all of his right, title, interest and estate in and to the said oil and gas leases above described, and the said oil and gas leasehold estates created thereby.
