to-said minors and that due and legal notice was given both by posting notices and by publication of the sale of said real estate as required by law, was filed and approved herein on February 26th, 1910, and that notice of the hearing on the return of sale was given by posting notices as required by law, and that said notices and publications appears regular, and no objections having been filed or exceptions made thereto, the same is duly approved by the Court.
