.the Lesse Acredit, and should any well produce gas in sufficient quantities to justify marketing, the lessor shall be paid the rate of one hundred 50 dollars (\$150.00) per year for such well so long as gas therefrom is sole, and lessor is to have gas for domestic use in one dwelling house on the premises free of cost duding the same time, making her own connections.

It is agreed that in case no well is completed on above described premises within twelve months from the date hereof this lease shall become absolutely null and void, unless Lessee shall pay for further delay a rental of one Dollar (\$1.00) per year payable quarterly in advance, until a well is completed on these premises and it is expressly agreed and understood that if such payments be continuously made until a well is completed on said premises, this lease shall continue until the expiration of the full term of the same.

All payments may be made in hand or by deposit to lessor credit in First National Bank of Owasso, Okla. or be deposited by registered letter in the P.O. to her address at Owasso, Okla. by check to her order.

The lessee they heirs, successors or assigns, shall have the right at any time on the payment of One dollar to lessor her heirs or assigns, to surrender this lease for cancellation, after which all payments and liabilities hereafter to accrue under and by virtue of iis terms shall cease and determine.

All covenants and agreements between the parties hereto shall extend to their heirs executors, administrators and assigns.
