WITNESSETH, that the said parties of the first part in consideration of the sum of Fifteen Hundred and No/100 Dollars, in them duly paid, the receipt of which is hereby acknowledged have sold and by these presents do grant sell and Mortgage to the said party of the second part, hit hers administrators or assigs forever, all that tract or parcel of land situated in the County of Tulsa, in the State of Oklahoma, described as follows, towit:
