ASSIGNMENT OF OIL AND GAS LEASE.

KNOW ALL MEN BY THESE PRESENTS, That I Hugh Mc Diveitt, of Tulsa County, Oklahoma, the owner of the undivided three eighths (3/8) of a certain oil and gas lease hereinafter described, have in the consideration of \$150.00 in hand paid by W.P. Miles, the receipt whereof is hereby acknowledged, granted, assigned and set over unto the said W. P. Miles, his executors, administrators and assigns the undivided one eighth of the aforesaid three eighths (3/8) thus leaving the said Hugh McDiveitt one (1/4) fourth in the following oil and Gas Lease, executed by Henry Wood, Guardian of Ora Wood, an minor of Tulsa, Okla., to W.H. Dodd, February 23rd, 1910, to the W/2 of NW of Sec. 16, Township 20, Range 13, containing eighty acres (80) situated in Tulsa County, Oklahoma, recorded in Book 79, page 247 of the records of said county and State.

Four eighths of said lease was assigned by W.H. Dodd to Hugh McDiveitt on the 7th day of April 1910, and said Hugh McDiveitt has this day has assigned one fourth (1/4) of his four eighths to one G.C. Simmons, thus at the time of making this assignment is the owner of an undivided three eighths (3/8) interest.
