and only persons interested in this matter, and have filed in this cause, their written waiver for the hearing of the petition for the sale of the oil and gas lease above referred to by said guardian upon the lands of said minor hereinafter described.

And the court further finds that the said minor is the owner of the following described tract of land, to-wit:

The N. W. 1/4 of the N.W. 1/4 and the N 1/2 of the S.W. 1/4 of the N W 1/4 if Section 9, Township 20 North, Range 14 East, containing 59 acres, more or less.

And the court futther finds that the above described land is in what is known as the oil and gas belt, and that it would be to the best interest of said minor and his estate, that a good and valid oil and gas lease should be made on said land and that said lease should be confirmed by this Court. That said land is unproductive and that said minor receives no, imcome from any source. That said minor has no property, real or personal other than abovedescribed, and that his income is insufficeent for his support, mainternance and education, and that said lease for oil and gas purposes should by this court be confirmed in order that said minor may have an income to pay for his support, maintenance and education, and that if said land is found to be productive of paying oil and gas wells, an income for said minor may be derived.

And the court further finds that the notice of sale of the oil and gas lease in this matter has been properly given, under and by virtue of the laws of the State of Ok-Lahoma, and in pursuance to an order of this court dated the 2 day of April, 1910.

And the court further finds that the said guardian did, on the 2nd day of April 1910 in the Courty Court room in the city of Tulsa, in said county and state, offer for sale, and oil and gas lease on the above described land at private sale to the highest and best bidder, and that at such sale Solan Oil Co. was the highest and best bidder, bidding therefor, amont acther things, one eighth royalty of the oil One Hundred Fifty Dollars per yealfor gas wells, when the gas is used off the premises, and a cash honus of \$1.00 per acre. That thereafter the said guardian did execute on oil and gas lease on the above described premises, of date April 2, 1910.

Now therefore, it is by this court, consdered, ordered, adjudged and decreed that said oil and gas mining lease, executed by James R. Stout as guardian of Russell S. Stout, a minor, to Solan Oil Co. of date April 2nd, 1910, shall be, and the same is in all its terms, covenants, agreents and conditions, ratified, confirmed, approved and declared valid.
