KNOW ALL MEN BY THESE PRESENTS, That I, Rachel Perryman, in consideration of the sum of one dollar (\$1.00) and other good and valuable considerations, and as security for my faithful performance of a contract of even date herewith, between myself and C. J. Wrightsman, do hereby grant and convey unto the said C.J. Wrightsman, his heirs and assigns an undivided two-fifths ($\frac{2}{5}$) interest in and to each and all of the several tracts hereinafter described, situated in Tulsa County, Oklahoma, to-wit:

1. The southwest quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) of section thirty six (36) township nineteen (19) north of range twelve (12) east, I.M.

2. The east half ($\frac{1}{2}$) of the northwest quarter ($\frac{1}{4}$) the southwest quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) and the south half ($\frac{1}{2}$) of the south half ($\frac{1}{2}$) of the northwest quarter ($\frac{1}{4}$) of the northwest quarter ($\frac{1}{4}$) of section twenty (20) township nineteen (19) north of range thirteen (13) east, I.M.

3. The east half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) and the east half ($\frac{1}{2}$) of the west half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) of section nineteen (19) Township nineteen (19) north of range thirteen (13) east, I.M.

5. Lot five (5) in the west half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) of section twelve (12) township nineteen (19) north of range twelve (12) east I.M.

TO HAVE AND HOLD THE SAME Unto the said C. J. Wrightsman, his heirs and assigns forever, free, clear and discharged of and from all former grants, claims, mortgages and other liens and encumbrances of whatsoever nature, and I warrant the title to the said premises against the lawful claims of any and all persons whomsoever, claiming or to claim the same, all of which covenants and warrants shall be binding upon my heirs executors, administrators and assigns forever.
