I

It is agreed that this lease shall remain in force for theterm of 5 years from this date, and as long thereafter as oil or gas on either of them is produced therefrom by the party of the second part, his heirs, executors, administrators, successors and assigns. In consideration of the premises the said party of the second part, covenants and agrees:

lst. To deliver to the credit of the first party, his heirs, executors, administrators, successors and assigns, free of cost, in the pipe line to which he may connect his wells, the equal one eighth part of all oil produced and saved from the leased premises.

2nd. To pay to first part One Hundred and fifty (\$150) dollars each year in advance for the gas from each well where gas only is found, while the same is being used off the premises, and the first party to have gas free of cost to heat----stoves in dwelling house on said premises during the same time.

3rd. To pay to first party for gas produced from any oil well and used off the premises at the rate of \$50.00 Dollars per year for the time during which such gas shall be so used, said payments to be made each three months in advance.

The party of the second part agrees to commence a well on said premises within six months from the date hereof and complete same within a reasonable time or pay at the rate of one dollar per acre in advance, for each additional twelve months such completion is delayed from the time abovementioned for the completion of such well until a well is comple ted, and it is agreed that the capletion of such well shall be and operate as a full liquidation of all rent under this provision during the remainder of the term of this lease.

The party of the second part shall have the right to use gas, oil and water from wells, springs or streams produced on said land by for its operation thereon, except water from wells of first party.

When requesed by first party the second party shall bury his pipe lines below plough depth on cultivated land

No well shall be drilled nearer than 300 feet to the house or barn on said land. The party of the second part shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing All payments which may fall due under this lease may be made direct to W.D. Flournoy or deposited to his credit in First National Bank Tulsa. It is further agreed that party of the second part in addition to above agreement as to drilling agrees to work continuously at the same aftertcommencement without stop or delay, unavoidable casualties excepted.

The party of the second part, his heirs, executors, administrators, successors and assigns, shall have the ritht at any time on payment of----Dollars, to party of the first part, his heirs, executors administrators, and assigns, to surrender this lease for cancellation after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine.

All covenants and agreements herein set forth between the parties hereto shall extend to their heirs, executors, administrators, successors and assigns. Withess our hands and seals the day and y4ar above set forth.
