ASSIGNMENT OF TRANSFER
INTEREST IN AN OIL AND GAS MINING LEASE.

KNOW ALL MEN BY THESE PRESENTS:

Foster, his executors, administrators or assigns.

And the said Frank S. Foster, for his interest aforesaid accepts the conditions and obligations of said lease.
