virtue of the homestead exemption laws of this state.

To have and to hold said premises for said purpose for the term of five years from this date and so long thereafter as gas or oil is produced thereon.

It is agreed, that while the product of each well in which gas only is found shall be marketed from said premises, the second party will pay to the first party therefor at the rate of Two Hundred dollars per annum and give the first party free gas at the well for domestic purposes for dwelling house during the same time.

Whenever the first party shall request it, second party shall bury all oil and gas lines which are laid over tillable ground. Second party also agrees to pay all damages done to crops by reason of laying and removing pipe lines. No well to be nearer thann250 feet of residence buildings on premises.

Second party also agrees to complete a well on said premises within six months from date or pay to first party at the rate of one dollar per acre per annum payable quar terly thereafter the completion of said well is delayed. All moneys falling due under the terms of this grant may be paid direct to the first party or deposited to the c edit of the first party int the Farmers & Merchants Bank of Bixby, Okla.

In further consideration for the payment of such sum of one dollar first above mentioned first party grants unto second party the exclusive option and right to release and terminate this grant or any undrilled portion thereof at any time; thereafter all liabil ties of second party as to the portion released shall ceade and determine.

Second party shall have the right to use sufficient right to gas, oil and water to drill all wells and for all purposes necessary or convenient in operating the same. The terms and conditions of this grant shall extend to the hairs, successors and assigns of the parties hereto.
