AGRICULTURAL LEASE.

THIS CONTRACT, made and entered into this 16th day of March, A.D. 1910, by and between Charles Bailey of Bixby, Okla. a citizen of the Creek Nation, Roll No .---- hereinafter called the lessor, and W.E. Privett, of Bixby, Oklahoma, hereinafter called the lessee, under and in accordance with the provisions of existing law, and the rules and regulations prescribed by the Secretary of the Interior relative to agricultural leases on restricted lands of allottees of the Five Civilized Tribes.

WITNESSETH: that for and in consideration of the rents, covenants and agreements hereinafter provided, on the part of the lessee to be paid and preformed, the lessor doth hereby let and lease unto the said lessee the lands and premises described as follows, towit: The SW/4 of the SE/4 of section 29-17-14. East

and containing 40 acres, more or less, for the period beginning on the 16th day of March 1910, fully to be completed and ended on the 15th day of March 1915, subject to the conditions hereinafter provided for.

The said lessee in consideration of said premises, as above set forth, covenant and agrees with the lessor to pay said lessor as rental for the same, the sum of Four Hundred Thirty five dollats (\$435.00) being at the rate of ------Dollars (\$-----) per acre, payable as follows, to-wit: Cash in full the receipt of which is hereby acknowledged by lessor.
