ORDER.

Now, to-wit: on this 12th day of April, 1910, comes on to be heard the petition of Willie Fox, and Luke Fox for the approval of a deed of conveyance from said Willie Fox and Luke Fox, heirs at law of Carthloney, deceased, to J. F. Kays; said petitioners appearing in person and by their attorneys, Biddison & Campbell, and after hearing the testimony, and the argument of counsel, the court being further advised in the premises, doth find:

That Carthloney was a duly enrolled full blood Creek Indian, and by reason of such enrollment had allotted to him, the following described land, to-wit:

South half of the Southeast quarter of Section Twenty six, Township 17 North, Range 13 East, in Tulsa County, Oklahoma.

That said Carthloney died intestate on the 8th day of February 1906, in that portion of the Creek Nation, now embraced in Tulsa County, Oklahoma, leaving surviving him, his wife, Tahsalay Carthloney, and his two sons, Willie Fox and Luke Fox, these petitioners, who are now of legal age, as his sole and only heirs at law, and left no other children of descendants of children.

That since the death of said Carthloney, said Willie Fox and Luke Fox, made executed and delivered to said J. F. Kays, a certain deed of conveyance, whereby they conveyed to said J.F. Kays, all their right, title and interest in and to said allotment aforesaid; the consideration therefor being ~~\$1444.33~~ ^{\$1333.33}.

It further appearing to the court from the testimony of Luke Fox and Willie Fox, sons of said Carthloney, that said Luke Fox and Willie Fox are satisfied with said sale and conveyance, and with said consideration therefor, and are desirous of having said deed approved and confirmed.

The court further finds; that the consideration of \$1333.33 for the interest of said Willie Fox and Luke in the land above described is adequate, and that the sum has been paid by said J.F. Kays, to said Willie Fox and Luke Fox.

It is therefore by the court considered ordered and adjudged; that the deed as presented herewith be and the same is hereby approved and confirmed.
