DEED OF RELEASE.

KNOW ALL MEN BY THESE PRESENTS:

That whereas, on the 4th day of April 1908 a certain mortgage was executed by Rachel C. Brady and W.T. Brady as mortgagors to P.E. Coyne as mortgagee, said Mortgage conveying the following described property situate in Tulsa County Oklahoma to-wit:
