Tranum the following described real property and premises situate in Tulsa County, State of Oklahoma, to-wit: All of Lot twenty three (23) in Block Fifteen (15) in Freeland's amended addition to Red Fork, Oklahoma, also all of Lot twelve (12) in Block Twenty (20) together with all improvements thereon and the appurtenances thereunto belonging and warrant the title to the same.

To have and to hold the said described premises unto the said grantee, his heirs, and assigns, forever, free, clear, and discharged of and from all former grants, charges, taxes, judgments, mortgages and other liens and incumbrances of whatsoever nature.

THIS INDENTURE, Made this 22nd day of April A.D. 1910, between A.B. Shawyer and Sadie Shawyer, his wife, and W. J. Stewart and Ella A. Stewart, his wife, parties of the first part, and Thos. J. McManus and A.J. McCartney and M.M. Shaver, parties of the second part.
