The note east quarter of the North East quarter and the North East Quarter of the North East Quarter, of Section numbered twenty two (22) and the North East Quarter of the North West Quarter of Section Twenty three (23) all in Township numbered nineteen (19) North and range Ten (10) East, of the Indian Base and Meridian, containing one hundred and sixty (160) acres, more or less, and being the individual allotment of Turner Timothy, deceased.

said deed being herewith exhibited to the court for its inspection, and the court having examined said petitioner, John Timothy in open court, and it appearing to the court that the said John Timothy is the sole and only heir at law to the allotment of Turner Timothy, deceased, and that the said Turner Timothy resided during all of his life in what is now McIntosh county, State of Oklahoma, and died therein in the month of February, and in the year of nineteen hundred; that the said deceased left not issue surviving him born since March 4th, 1906; that the said Turner Timothy departed this life in the month of February, 1900, leaving surviving him at the time of his death, his father, John Timothy, and one brother, Warsey Timothy; that the said Warsey Timothy departed this life about the year 1904, leaving surviving him his father, John Timothy, who is the sole and only heir at law to the allotment of Turner Timothy, deceased.

That the said Turner Timothy was a full blood Creek Indian, duly enrossed upon the tribal rolls of the Creek Nation, opposite Roll Number 7687; that the said John Timothy is a full blood Creek Indian, duly enrolled upon the tibal rolls of the said Creek Nation opposite Roll Number 7685; that the said land hereinbefore described is the allotment of the said Turner Timothy of the lands of the lands of the Creek Nation; that the said John Timothy is the owner, in fee simple, of said land. That the consideration of four hundred and twenty five dollars (\$425.00) paid by the grantee, B.H. Harrison, is an adequate consideration for said land; that the sale and conveyance of said land has been fairly conducted, and that all of the parties thereto have acted in good faith, and that the said sale is beneficial to said petitioner, John Timothy, and that the deed therefor is in proper form, and should be approved by this honorable court; and, the court being well and sufficiently advised in the premises, it is, by the Court,

CONSIDERED ADJUDGED AND ORDERED, that the prayer of the petition of the said John Timothy be, and the same is hereby granted, and that the warranty deed from the said John Timothy to the said B.H. Harrison to the lands hereinbefore described and mentioned and presented in open court, be, and the same is hereby, in all things ratified, confirmed and approved, and it is

FURTHER OF DERED, that a certified copy of this order be endorsed upon or attached to said deed.
