ORDER.

Now on this the 31 day of March 1910, this matter came on to be heard upon the joint petition of Chepon Rogers and Annie Rogers, (nee Bruner), as two of the heirs at law of one Luch Rogers, deceased, praying an order of this Court approving a certain deed of conveyance made, executed and delivered by them, under date of 31 day of March 1910, and conveying their interes in and to the lands hereinafter described to J.B. Saunders and W.R. Childers; said lands being the allotment of the said Lucy Rogers, deceased.

The petitioners appearing in person and by their attorneys, and the Court having heard the testimony of netitioners and other witnesses duly sworn and examined, and the argument of counsel and being fully advised in the premises finds;

That the allegations and statements in said petition contained are true; that the said Lucy Rogers, deceased, was a Full blood Creek Indian and duly enrolled as such opposite Roll No. 1006; that by reason whereof said Ducy Rogers, deceased, was allotted as her distributive share of the lands of the Creek Nation the following described lands, situate in what is now Tulsa County, State of Oklahoma, to-wit:

The South Half of the Southwest Quarter, and the South Half of the Northeast Quarter of the Southeast Quarter of Section Twenty (20), and the South Half of the Northwest Quarter of the SouthwestQuarter of Section Twenty one (21); and theNorthwest Quarter of the Northeast quarter of Section Twenty nine (290 all in township Mineteen (19) North; Range Eleven (11) East, containing 150 acres more or less, and that the said Lucy Rogers, deceased died intestate without issue, and seized of said lands.
