

## WARRANTY DEED

THIS INDENTURE, Made and entered into this, the 23rd day of September

A., before the same became a part of the State of Oklahoma, and now continuing business under and by virtue of such incorporation within the State of Oklahoma, as by law provided, with its Home Office and Principal Place of Business at Tulsa, Tulsa County, Oklahoma, by and through its Attorney in fact, C. W. Deming, as the first party and Mrs. H. B. Landley, of Louisa County, and State of Georgia, as the second party

WITNESSETH: That the first party for and in consideration of the sum of Seven Hundred Fifty & 21/100 (8750 <sup>21</sup>/<sub>100</sub>) DOLLARS, cash to it in hand paid at or before the sealing and delivery of these presents, the receipt of which is hereby confessed, has granted, bargained, sold conveyed and confirmed and does hereby grant, bargain, sell, convey and confirm unto the second party her, heirs and assigns forever all the following described real property and premises lying and being in the County of Tulsa, and State of Oklahoma, and more particularly described as follows:

All the above and foregoing being in TULSA HEIGHTS, as appears by the Plat of the same on file in the Office of the Register of Deeds, Tulsa County, Oklahoma. Said TULSA HEIGHTS is laid out and platted upon the west half of the southwest quarter and the southwest quarter of the northwest quarter of Section twenty-nine (29) Township twenty (20), North and Range Thirteen (13) East, of the Indian base and meridian.

TO HAVE AND TO HOLD the above bargained real property together with all and singular the rights, members, hereditaments, tenements and appurtenances thereunto belonging or in anywise appertaining and every right, title and interest of the first party therein and thereto, unto the said second party her heirs and assigns, FOREVER in FEE SIMPLE.
