WITNESSETH, The said party of the first part, in consideration of the sum of
Twenty-nine hundred fifty and ~~25~~ ⁰⁰ Dollars,
the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part,
heirs and assigns, all of the following described real estate, situated in the County of Tulsa City of Tulsa and
State of Oklahoma, to-wit:

Beginning at a point (46.6) forty-six and six tenths feet east of
the corsses at Brady and North Boston Streets on Block (27) Twenty
sevent. Thence running easterly on Brady Street a distance of
Forty-six and six tenths feet (46.6) Thence northerly parallel with

said party of the first part his their heirs and all and every person whomsoever, lawfully claiming or to claim the same.
