WITNESSETH, The said part of the first part, in consideration of the sum of One Dollar (\$1.00) and other valuable considerations and

the receipt of which is hereby acknowledged, do hereby presents grant, bargain, sell and convey unto the said part of the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa and

State of Oklahoma, to-wit:

The southwest quarter (SW 4) of the southeast quarter (SE 4) of section thirty six (36) of township twenty (20) range twelve (12) T. 20. R. 12. and also all of that part of lot one (1) which lies north of the Frisco Railroad in section one (1) of township nineteen (19) range twelve (12) east comprising 48.75 acres of land

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.
