MORTGAGE OF REAL ESTATE—SAML BODSWORTH BOOK CO., LEAVENWORTH, KAN. No. 19788

THIS INSTRUMENT, Made this 27th day of May, A. D. 1910, between Effie Stryker and William Stryker her husband of Tulsa County, in the State of Oklahoma, of the first part, and J. A. V. Hatcher of Tulsa County, in the State of Oklahoma, of the second part:

WITNESSETH, That said parties of the first part, in consideration of Two thousand

Dollars (\$2000.00),

the receipt of which is hereby acknowledged, do hereby present, grant, bargain, sell and convey unto said party of the second part, her heirs and assigns, the following-described Real Estate, situated in Tulsa County, and State of Oklahoma, to-wit:

The Northern forty eight (48) feet of Lot Four (4) in Block one hundred and twenty one (121) in the City of Tulsa, Oklahoma according to its official Survey thereof.

TO HAVE AND TO HOLD THE SAME unto the said party of the second part, her heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED, ALWAYS, And these presents are upon this express condition, that whereas said Effie Stryker and William Stryker have this day executed and delivered one certain promissory note, in writing to said party of the second part, described as follows:

\$2000.00 Payable one year after date with 8 per cent interest per annum from date until paid. interest payable annually. This mortgage is given subject to one certain mortgage of \$2500.00 dated May 16th 1910 to M. B. Hays, Sheriff Oklahoma.

Now, if said parties of the first part shall pay or cause to be paid to said party of the second part, her heirs or assigns, said sum of money in the above-described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then this mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof are not paid when the same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable, and said party of the second part shall be entitled to the possession of said premises. And the said parties of the first part for said consideration do hereby expressly waive an appraisalment of said real estate and all benefit of the homestead exemption and stay laws of the State of Oklahoma.
