MORTGAGE OF REAL ESTATE.

THIS INDENTURE, Made this 3rd day of December A. D. 1917 between James D Ward and Sadie Ward his wife of Collinsville, Rogers County, in the State of Oklahoma, part 1 of the first part, and H. E. Hulen and J. A. Reaves of the State of Oklahoma, of Tulsa, Oklahoma, party of the second part:

WITNESSETH, That said party of the first part in consideration of the sum of Fifteen Thousand Two Hundred fifty four & 4/100 DOLLARS, the receipt whereof is hereby acknowledged, do hereby these presents grant, bargain, sell and convey unto said party of the second part his heirs and assigns, all the following-described real estate, situated in the County of Tulsa State of Oklahoma, to-wit:

The W 1/2 of Lot 3 and the E 1/2 of Lot 4 Section
6 Town 21 R 14 east Free and Clear
containing 4 1/2 acres more or less as the
case may be

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

This conveyance is intended as a mortgage to secure the payment of one promissory note... of even date herewith. One for \$ 15,264.40 due June 3rd 1917 a copy of which is hereto attached made to UNION TRUST COMPANY, or order, payable at its offices in Tulsa, Oklahoma, with per cent. interest per annum thereon from per cent. payable semi-annually, and per cent. attorney fees if placed in the hands of an attorney for collection and paid without suit, and an additional attorney's fee of \$ per cent. if suit is brought to foreclose this mortgage.

Said parties of the first part hereby covenant that they are owner... in fee simple of said premises and that they are free and clear of all incumbrances. That they have good right and authority to convey and encumber the same, and they will warrant and defend the same against the lawful claims of all persons whomsoever. Said parties of the first part agree... to insure the buildings on said premises in the sum of \$ per cent. for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage. Said part and of the first part to pay all taxes and assessments lawfully assessed on said premises before delinquent.

Now if said part... of the first part shall pay or cause to be paid to party of the second part, its successors or assigns, said sum of money in the above-described note..., and shall make and maintain such insurance and pay such taxes and assessments, then these presents shall be wholly discharged and void; otherwise shall remain in full force and effect. If such insurance is not effected and maintained, or if any or all taxes and assessments which are or may be levied and assessed lawfully against said premises or any part thereof are not paid before delinquent, then the mortgagee... may effect such insurance or pay such taxes and assessments and shall be allowed interest thereon at the rate of ten per cent. per annum, until paid, and this mortgage shall stand as security for all such payments; and if said sum or sums of money or any part thereof is not paid when due, or if such insurance is not effected or maintained, or any taxes or assessments are not paid before delinquent, the holder of said note... and this mortgage may elect to declare the whole sum or sums and interest thereon due and payable at once and proceed to collect said debt, including attorney's fees and to foreclose this mortgage; and shall become entitled to the possession of said premises.

Said part... of the first part waive... notice of election to declare the whole debt due, as above stated, and also the benefit of stay, valuation or appraisal laws.
