ASSIGNMENT OF OIL AND GAS LEASE.

Know all men by these presents that I, W. H. Dodd, lessee and owner of the undivided Four Eighth (4/8) interest in a certain oil and gas lease hereinafter described, have in the consideration of the covenants and promises to be performed, hereinafter as described, at and before the sealing and delivery hereof, have granted, assigned, and set over and by these presents do grant, assign and set over unto the said James E. Grant, Sidney Butler, and A. A. Hunter, their executors, administrator or assigns the undivided three fourth (3/4) of the aforesaid four eighths (4/8) interest in the hereinafter described oil and gas lease as follows: Oil and gas lease dated February 23, 1910, executed by Henry C. Wood, Guardian of Ora Wood, a minor, of Tulsa, Oklahoma to W. H. Dodd of Tulsa, Oklahoma, consideration Five Hundred Dollars (\$500.00) on the following land; The West Half (1/2) of the North West Fourth (1/4) of Section Sixteen (16) Township Twenty (20) Range Thirteen (13) East, containing Eighty (80) acres, sit situated in Tulsa County, Oklahoma. Said lease was filed for record on the ____ day of March, 1910, at the Register of Deeds Office in Tulsa, Tulsa County, Oklahoma, recorded in Book ____ Page ____ of the records of said County.

This assignment is made upon the express condition that the said James E. Grant, Sidney Butler, and A. A. Hunter, shall truly and well perform all the covenants contained within the aforesaid mentioned oil and gas lease, to the extent of carrying the aforesaid W. H. Dodd's remaining One Eighth (1/8) interest in the aforesaid oil and gas lease free from any cost or expense to the said W. H. Dodd, and upon the performance of all the covenants and agreements, in said oil and gas lease as above described and mentioned, by James E. Grant, Sidney Butler, and A. A. Hunter they shall have and hold an undivided three fourth (3/4) interest of the aforesaid four eighth (4/8) interest in the said oil and gas lease as above provided, that they bear all cost and expense in operating, covering, their interest and including the one eighth (1/8) interest of the said W. H. Dodd, free from all cost or expense whatsoever to the said W. H. Dodd.

This assignment shall be binding upon the executors, administrators, or assigns of both parties.
