Stevenson and unto their heirs and assigns forever, the following described real estate lying in the Western District of the Indian Territory, to-wit:

Lot Seven (7) in Block One Hundred Thirty-four (134) in Tulsa, Ind. Ter., as per Government Plat thereof.

This deed being made to release (only so far as it affects the above described property) the lien of a certain Mortgage dated April 19th 1906, and recorded April 23rd, 1906, at 9 A. M. in Book 14, at Page 444 of the records of Mortgages at Sapulpa, Ind. Ter.

This deed of release is made by the undersigned officer of the UNION TRUST COMPANY in pursuance of the authority conferred upon him in Article VII of the by-laws of said Company, as follows:
