On this 13th day of April, 1910, this cause coming on to be heard upon the petition of Monie Chisholm, nee Samuel, Creek Roll No. 9266, as the sole and only heir at law of John Chisholm, deceased, the petitioner appearing in person in court; the court, after hearing the testimony and being fully advised in the premises doth find:

That John Chisholm was a full-blood Creek Indian Citizen and duly enrolled as such, Roll No. 9999; that to him was allotted the West Half of the Northeast Quarter and the Southeast Quarter of the Northeast Quarter of Section Twenty; and the Southwest Quarter of the Northwest Quarter of Section Twenty-one, all of Township nineteen north, Range ten east, situated in Tulsa County, Oklahoma, as such citizen.

That said John Chisholm died intestate, without issue, in Okfuskee County, Oklahoma, on the 26th day of August, 1903; that he left surviving him as his only and sole heir at law, his mother, Monie Chisholm, nee Samuel and Geo. Chisholm, his grand father, who is a full blood Indian Citizen of the Creek Nation and of lawful age.

The "court further finds that on the 7th day of February, 1910, Monie Chisholm, nee Samuel, executed her certain warranty deed to John F. Hayden, for the consideration of four hundred (\$400.00) dollars, conveying all her right, title, and interest in to the above described real estate.

The court further finds that the consideration of four hundred (\$400.00) dollars for one half interest in and to the above described lands is adequate and sufficient and that the said four hundred dollars has been paid.

It is therefore ordered, adjudged, and decreed by the court that the deed from the said Monie Chsiholm, nee Samuel, above named conveying the said lands and the title to the same as aforesaid, be, in all things, approved and confirmed by this court.
