## ORDER CONFIRMING REPORT OF COMMISSIONERS.

A. P. Stephenson, J. N. Jones and G. P. To Simmer Carnard, The east half of the Northeast quarter of the Northeast Quarter and the East half of the West half of the Northeast quarter of the Northeast quarter of Section twenty-two in township ten, north of range ten, east in Okfuskee County, Oklahoma; and also the North half of the Southeast Quarter of the Southwest quarter, and the South half of the South half of the Northeast quarter of the Southwest Quarter of section sixteen, in Township Nineteen, north of Range Eleven, east, in Tulsa County, Oklahoma, being sixty acres.
