sufficient water from the premises to run all necessary machinery, and at any time to remove all machinery and fixtures placed on said premises; and, further, upon the payment of One (\$1.00) Dollars at any time after giving three months! notice by the parties of the second part, their successors of assigns, to the party of the first part his heirs or assigns, said parties of the second part, their successors or assigns, shall have the right to surrender this grant for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine, and this grant become absolutely null and void.
