WARRANTY DEED.

And said Sar-yo-Kiche for her heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the second part, that at the delivery of these presents _____ lawfully seized in her own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances of what nature and kind soever and that she will warrant and forever defend the same unto said party of the second part, his heirs and assigns, against said party of the first part, — heirs and all and every person whomsoever, lawfully claiming or so claim the same.
