ASSIGNMENT OF OIL AND GAS LEASE

This instrument made and entered into this 11th day of May 1910, by and between J.E. Prosser and W.L. Knight, of Tulsa, Oklahoma, partners under the firm name and style of Prosser & Knight, parties of the first part and J. H. Brennan, of Tulsa, Oklahoma, party of the second part, WITNESSETH:

That whereas, on the 4th day of October, 1909, Melessee Thomas, as guardian of Joseph Perryman and Ralph Perryman, minors, executed and delivered to the Daisey Bell Oil Company a corporation, a certain oil and gas mining lease covering the NE $\frac{1}{4}$ of section 27, township 18 North, Range 12 East of the Indian Base and Meridian; and/

Whereas, the said Daisy Bell Oil Company has by an instrument of writing dated the 20th day of April, 1910, agreed to transfer and assign unto the first party an undivided $\frac{7}{16}$ interest in and to the aforesaid oil and gas lease and the leasehold estate thereby created upon certain conditions therein set forth; and

Whereas, the said Daisy Bell Oil Company has by an instrument of writing of date April 22, 1910, which has been deposited in escrow at the Exchange National Bank of Tulsa, Oklahoma, to be delivered to the first parties upon the happening of the conditions therein set forth, transferred, assigned and conveyed unto the first party an undivided $\frac{7}{16}$ interest in and to the aforesaid oil and gas lease and the leasehold estate thereby created.

NOW THEREFORE, for and in consideration of One Dollar cash in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, the said first parties, hereby transfer, assign, and convey unto the second party, an undivided $\frac{1}{16}$ interest in and to the aforesaid oil and gas lease and the leasehold estate thereby created.

TO HAVE AND TO HOLD the said undivided $\frac{1}{16}$ interest in and to the said oil and gas lease and the lease hold estate thereby created, unto the said J.H. Brennan, his heirs and assigns, during the full term of said lease, and subject to its provisions and conditions.
