That the said Emarthla was a full blood Creek Indian as shown on the citizenship rolls of said Nation, opposite roll number 6874, that as such citizen he had allotted to him by the Commission to the Five Civilized Tribes, as his separate allotment of land, the following described real estate situated in Tulsa County, to-wit: Lot 22 of Section 7, and the Northeast quarter of the Southeast quarter of section 22, and the west half of the Southwest quarter of section 23, all in Township 19, North, Range 12 East, containing one hundred and sixty acres of land.

That the said Emathla died intestate in gulsa County on the 2nd day
