This cause coming on to be heard this day upon the petition of Solomon Bullett, C-8663, John Bullett, C-8776, Annie Wolf, C-8666, and Sallie Brown nee Gaine, C-6755, heirs at law of Harriett Gano, deceased, praying for an order of this Court approving a warranty deed executed by the said Solomon Bullett, John Bullett, Annie Wolf, and Sallie Brown nee Gaino to John F. Hayden and John F. Black on the 30th day of March, 1910, wherein and whereby the said Solomon Bullett, John Bullett, Annie Wolf, and Sallie Brown nee Gaine, as heirs at law of the said warriett Gano, deceased, did grant, bargain, sell and convey unto the said John F. Hayden and John F. Black an undivided 2/3 interest in the following described lands, situated in Tulsa County, Oklahoma, to-wit:

And it appearing to the Court that the said #arriett Gano in her lifetime was a duly enrolled full blood Indian Citizen of the Creek Nation; and that as such citizen of the Creek Nation had allotted to her the above described lands, and it further appearing to the Court that the said Harriett Gano departed this life on the 17th day of April, 1899, within that portion of the Creek Nation where she then resided now within the limits of Hughes County, Oklahoma; that the said Harriett Gano left surviving her the afore mentioned Solomon Bullett, John Bullett, Annie Wolf, Aggie smith nee Gaino and Sallie Brown nee Gaino, her children; that the said Harriett Gano during her lifetime had no other children other than the afore mentioned; that the Father and Mother of the said Harriett Gano are long since deceased. And it further appearing that the said Solomon Bullett, John Bullett, Annie Wolf, and Sallie Brown nee Gaino are full blood Indian citizens of the Creek Nation, and are of full age; and the Court being fully advised in the premises, finds:

That it has full and complete jurisdiction of the parties hereto and the subject matter hereof; that the said Solomon Bullett, John Bullett, Annie Wolf, and Sallie Gaino are heirs at law of the said Harriett Gano, deceased; that
