secretary of the Interior first obtained, and that any such assignment or transfer made or attempted without such consent shall be void.

And the said party of the second part further covenants and agrees that it will keep an accurate account of all oil mining operations, showing the whole amount of oil mined or removed; and all sums due as royalty shall be a lien on all implements, tools, movable machinery, and other personal chattels used in said prospecting and mining operations, and upon all of the oil obtained from the land herein leased, as security for the payment of said royalties.

And the party of the second part agrees that this indenture of lease shall in all respects be subject to the rules and regulations heretofore or that may hereafter be lawfully prescribed by the Secretary of the Interior, relative to oil and gas leases in the Cheokee Nation.

And the said party of the second part agrees that should it or its sublessees, heirs, executors, administrates successors or assigns violate any of the covenants, stipulations, or provisions of this lease, or fail for the period of sixty days to pay the stipulated monthly royalty provided for herein, then the party of the first part shall be at liberty in his discretion to avoid this indenture of lease and cease the same to be annulled, when all the rights, franchises, and privileges of the party of the second part, its sublessees, heirs, executors, administrators, successors, or assigns hereunde shall cease and end without further proceedings.

If the lessee makes reasonable and bona fide effort to find and produce oil inpaying qhantity as is herein required of it, and such effort is unsuccessful, it may at any ime thereafter, with the approval of the Secretary of the Interior surrender and wholly therminate this lease upon the full payment and performance of all its then existing obligations hereunder, Provided however, that approval of such surrender by the Secretary will be required only during the time his approval of the alienation of the land is required by law.

It is further agreed and understood that this lease shall be of no force or effect unless the party of the second part shall, within sixty days from the date of approval of the applicationfiled in connection herewith, furnish a satisfactory bond in accordince with the regulations of March 20, 1905, prescribed by the secretary of the Interior, which shall be deposited and remain on file in the Indian Office during the life of this lease.
